## Making an Impact and Providing Opportunities in Our Community

Illinois American Water is committed to building meaningful partnerships with diverse businesses as we provide essential water and wastewater services to approximately 1.3 million customers. Since joining the company in November 2022, and proudly stepping into the role of a board member of the Illinois Utilities Business Diversity Council (IUBDC), I have witnessed the impact made through not only increasing our diverse spend, but continuing to prioritize the hiring of diverse candidates, as well as nurturing new and existing partnerships in our community. Our success as a business is directly related to the diversity of the people who make up our workforce, and the intentional way in which we conduct business, to keep our customers and communities safe.

I am proud to share that in 2022, Illinois American Water had a total diverse spend of more than \$97.6 million, which represents 34.7% of our total spend. This exceeded our goal by 7.7% and was a 50.1% increase in our total diverse spend from 2021. The majority of this increase came from our valued partnerships with veteran-owned businesses (a 108.5% increase in spend from 2021) but was also supported through strengthened relationships with women-owned businesses (a 58.2% increase in spend from 2021) and minority-owned businesses (an increase of 9.4% in spend from 2021).

Our partnerships with diverse suppliers extend beyond the bottom line. One way in which we strengthen relationships among new and existing diverse suppliers is through American Water's Supplier Diversity Symposium. Supplied Industrial Solutions, a veteran-owned general subcontractor and material supplier with a long-standing relationship with Illinois American Water, received the Supplier of the Year award in 2022 at the annual networking event. These relationship-building events and activities give us a platform to celebrate the diverse businesses in our communities and to recognize them for demonstrating similar values held by our company.

The results presented in this report do not happen by chance. Employees across Illinois American Water are committed to increasing diverse spend and expanding the representation of women, veterans and minorities in our employee base. With this purposeful action comes positive change and a lasting impact on the economic viability of diverse businesses. We aim to have our employees reflect the communities we serve, and we approach our diverse spend with that same enthusiasm.

## **III. TERMS & DEFINITIONS**

BOOSTER STATION	A booster station is a collection of booster pumps strategically located in a water distribution system. Pump stations work to maintain consistent pressure and provide adequate flow. These stations may also move water from ponds, reservoirs and water towers into the system.
CERTIFIED	Means currently certified as MWDVBE by an authorized certifying body, such as the National Minority Supplier Development Council (NMSDC) or its affiliate regional councils, the Women's Business Enterprise National Council (WBENC).
CONTROL	Means overall fiscal/legal responsibility and exercising the power to make policy decisions.
DISABILITY OWNED BUSINESS ENTERPRISE (DOBE)	Businesses that are 51% owned, controlled, operated and managed by a person(s) with a disability.
DISADVANTAGED BUSINESS ENTERPRISE (DBE)	Means a business that is usually certified by a federal, state or local government agency as having met all of the government standards that award eligibility, but may include women, minority, disabled and other disadvantaged as a result of economic disadvantages with respect to education, employment, residence or business location, or social disadvantage and lack of business training.
HISTORICALLY UNDERUTILIZED BUSINESS (HUB)	Means a business located in a "historically underutilized business zone," owned and controlled by one or more U.S. citizens, and at least 35% of its employees must reside in a HUBZone. It must appear on the list of Qualified HUBZone Small Business Concerns maintained by the SBA.
LESBIAN, GAY, BISEXUAL AND/OR TRANSGENDER- OWNED BUSINESS ENTERPRISE (LGB/LGBTBE)	Means a business that is majority (at least 51.0%) owned, operated, managed and controlled by a lesbian, gay, bisexual and/or transgender (LGBT) person or persons who are either U.S. citizens or lawful permanent residents, exercises independence from any non-LGBT business enterprise, has a principal place of business (headquarters) in the United States and has been formed as a legal entity in the United States.
LIFT STATION	Facilities designed to move wastewater from lower to higher elevation through pipes.
MINORITY-OWNED BUSINESS ENTERPRISE (MBE)	Means a business concern in which at least 51.0% of the ownership and control is held by individuals who are members of a minority group and of which at least 51% of the net profits accrue to members of a minority group. Such persons include, but are not limited to, Black Americans, Hispanic Americans, Asian Pacific Americans (persons with origins from Japan, China, the Philippines, Vietnam, Korea, Samoa, Guam, the former U.S. Trust Territory of the Pacific Islands [Republic of Palau, the Commonwealth of the Northern Mariana Islands, Republic of the Marshall Islands, Federated States of Micronesia], Laos, Cambodia [Kampuchea], Taiwan, Burma, Thailand, Malaysia, Indonesia, Singapore, Brunei, Macao, Hong Kong, Fiji, Tonga, Kiribati, Tuvalu or Nauru), Subcontinent Asian Americans (persons with origins from India, Pakistan, Bangladesh, Sri Lanka, Bhutan, the Maldives Islands or Nepal), Native Americans (American Indians, Eskimos, Aleuts and Native Hawaiians), and members of other groups designated by the U.S. Small Business Administration as minorities.

OWNED	Means at least 51.0% of the business or, in the case of a publicly owned business, at least 51.0% of the stock is owned by a minority, woman or service-disabled veteran.
RFI, RFQ, RFP	Request for information, quote or proposal.
SERVICE-DISABLED VETERAN-OWNED BUSINESS ENTERPRISE (SDVBE)	Means a business concern that is (a) at least 51.0% owned by one or more service-disabled veterans or, in the case of any publicly owned business, at least 51.0% of the stock of which is owned by one or more service-disabled veterans or (b) in the case of a veteran with a permanent and severe disability, the spouse or permanent caregiver of such veteran.
SMALL DISADVANTAGED BUSINESS (SDB)	Means a "for profit" business that qualifies as "small" per the SBA Table of Small Business Size Standards Matched to North American Industry Classification System Codes.  That is at least 51.0% unconditionally owned by one or more U.S. citizens who are socially and economically disadvantaged individuals.  Whose management and daily business operations are controlled by one or more U.S. citizens who are socially and economically disadvantaged individuals.  The personal net worth of each individual claiming economic disadvantage is less than \$750,000 (except for tribes, Alaskan Native Corporation-Owned Concerns [ANCs], Community Development Corporation-Owned Concerns [CDCs] and Native Hawaiian Corporation-Owned Concerns [NHOs]).  Note: ANCs, NHOs or CDCs must meet the "ownership," "management" and "control" criteria in Title 13 of the Code of Federal Regulations, Part 124.109, 124.110 and 124.111, respectively.
SMALL BUSINESS (SBE/SMB)	Depending on the industry, "small" is defined by either the number of employees or average annual receipts of a business concern. Website references for size standards by NAICS code is: sba.gov/federal-contracting/contracting-guide/size-standards
SMALL DISADVANTAGED BUSINESS 8A (SDB-8A)	Means a designation given to small companies owned by socially and economically disadvantaged persons, so that they may bid and obtain federal government contracts and other assistance to develop their business. The business owner must be eligible under the same rules and guidelines set down by the federal government.
VETERAN-OWNED BUSINESS ENTERPRISE (VBE)	Means a business concern that is at least 51.0% owned and controlled or, in the case of a publicly owned business, at least 51.0% of the stock is owned by an owner or owners who are veterans of the U.S. military, ground, naval or air service, who (a) served on active duty for a period of more than 180 days and were discharged or released with other than a dishonorable discharge or (b) were discharged or released from active duty because of a service-connected disability.
WOMEN-OWNED BUSINESS ENTERPRISE (WBE)	Means a business concern that is at least 51.0% owned and controlled by a woman or women or, in the case of any publicly owned business, at least 51% of the stock is owned by a woman or women. Such women's business enterprise shall further be classified as either minority or non-minority women-owned business, depending upon the greater portion of ownership.

## A. American Water – Expenditures & Vendor Utilization

Table A demonstrates the total expenditures of American Water and all 13 of its corporate entities.

Regulated business spend with certified diverse suppliers is 21.3% of total sourceable spend. This reflects 0.4% below the 2022 goal of 21.7%, however \$6.4M in HUBZone and DBE spend were excluded from the above chart and not counted in total diverse supplier spend.




Within the state of Illinois, expenditures with diverse-owned businesses increased 60% in 2022. The consistent increase in spending with Illinois-based diverse businesses is the result of active participation and engagement with local and regional advocacy partners. Several local suppliers have engaged with advocacy partners because of meetings with Illinois American Water Supply Chain and Operations business leaders to learn about the certification process and consistently following through to full certification.

More than 60% of Illinois-based spend is with diverse suppliers in 2022 in comparison to 54% in 2021. Spending with Illinois-based suppliers has increased by 91% since 2019.


#### Illinois American Water's 2022 Illinois-based MBE Spend


#### Illinois American Water's 2022 Illinois-based WBE Spend

#### Illinois American Water's 2022 Illinois-based VBE Spend




#### **E. Professional Services**

In 2022, professional services spend totaled \$12.1 million, a 107.9% increase from 2021 spend of \$5.8 million. With Engineering, Legal and Corporate Consulting representing the top three spend categories, these categories contributed to 94% of the professional services spend. #### Category YOY Spend 2021 – 2022




#### Historical Data 2020 - 2022



In 2022, a total of **129 Illinois-based** diverse business firms were included in the diverse supplier mix.





## V. POLICIES & METHODOLOGY

#### **POLICIES**

American Water Works Service Company, Inc., its subsidiary and affiliated companies are committed to creating an inclusive procurement process that is accessible and fair to all suppliers based on their ability to meet the company's performance, price and quality requirements. Our employees are responsible for identifying, qualifying, selecting and managing the procurement process for goods and services to assure that qualified diverse suppliers are appropriately included. Our employees must comply fully with all company policies and practices relating to the inclusion of diverse suppliers. We also strongly encourage our prime contractors and major suppliers to support supplier diversity by creating a competitive procurement process that provides opportunities to the greatest extent possible for diverse supplier sub-contractors and businesses. Excellence in supplier diversity will lead to excellence in supply chain management and will advance American Water's financial and operational goals while providing opportunities for success to a wide and diverse range of businesses in the communities we serve.

#### **METHODOLOGY**

### A. Supplier Diversity Language

In accordance with American Water's Procurement Policy and supplier diversity practices, specific contracting language is required to include diverse suppliers in subcontracting opportunities and provide evidence of actions taken to meet targets. The supplier diversity utilization goals for diverse suppliers are 25.0%, with 10.0% specific to MBEs in Tier II spending for all competitive bidding events and finalized agreements.

The American Water Supplier Diversity Subcontracting Plan is a required submittal with all Requests for Proposals, quarterly reports and final payment applications (see Appendix A).

## **B.** Organizational Responsibilities

It is the responsibility of the Senior Manager, Corporate Supplier Diversity, and Illinois American Water Program Director of Supplier Diversity to provide overall program management, strategy development, implementation and monitoring to assist Supply Chain and business unit partners in their efforts to increase opportunities and contract awards to small and diverse businesses. The governance of the corporate supplier diversity program is the responsibility of the Senior Manager, Corporate Supplier Diversity who reports to the Chief Procurement Officer.

- a. Supply Chain shall assist business units with the identification and inclusion of diverse suppliers in the sourcing of services and materials. They shall also facilitate cross-functional category teams with members representing Supply Chain, Supplier Diversity, Engineering and other business units as appropriate for the inclusion of diverse suppliers in sourcing events for national categories.
- b. It is the responsibility of the American Water business unit representative to work with Supply Chain, Tier I and Tier II suppliers, and business advocacy groups to ensure opportunities are provided to diverse suppliers. The business unit is also responsible for the day-to-day oversight of these suppliers.

#### C. Reporting/Metrics

#### **D. Diverse Spend Collection**

Tier I spend data is recorded through American Water's procurement system when payment is made to a supplier.

In accordance with the American Water Supplier Diversity Subcontracting Plan and the current fully executed contract, Tier I prime suppliers are required to submit quarterly Tier II diversity spend reporting through the Supplier Diversity Portal amwater.com/corp/Partners-Suppliers/Supplier-Diversity/. Diversity spend data is collected during the bidding process through the Supplier Diversity Subcontracting Plan.

The foundation for the success of American Water's commitment to diverse supplier growth is forged around three primary goals: Access, Development and Growth. The conclusion of the first 5-year plan in 2022 has primarily been focused on access and growth:

Aside from expanding the growth of existing suppliers across multiple American Water subsidiaries' regional and enterprise-wide opportunities, the focus of the next five-year strategy is on furthering the development of existing and potential new diverse suppliers.

American Water Supplier Diversity leadership teams are engaging with a major university to create a formalized development program focused on business fundamentals to assist small- and medium-sized suppliers to protect, grow and sustain their business for long-term opportunities, and increasing the scale and scope of services. The development program will also have an emphasis for larger established suppliers who have achieved success in other utility sectors and who intend to transition to the water utility space for additional growth opportunities.




Exhibit B: Illinois American Water's Diversity Percentage of Spend with Certified Suppliers

## IX. CHALLENGES AND OPPORTUNITIES

Emerging from the global COVID 19 pandemic, diverse and small businesses that have managed the major challenge to survive have in some cases done so by redefining themselves. Finding ways to reduce cost and transition to remote work environments are just a few of the innovative solutions that now define their success.

Several issues continue to be pervasive pre and post pandemic that are now magnified given the state of America's economy and cultural transformations.

The acquisition of capital to enter the utility market or to scale for growth has been a persistent barrier to entry. The rise of inflation has added additional stress to companies of all sizes, but especially for diverse and small businesses.

Although inflation rates remained consistent over the past decade, they skyrocketed in 2022. Inflation rates for all major goods and services increased by 8.5% for the year ended March 2022 according to the U.S. Bureau of Labor Statistics.



Inflation impacts every part of a diverse and small business: prices for material goods, labor and other services go up. These businesses must find ways to offset the costs. In addition to inflationary pressure, diverse-led businesses and, more specifically, minority-led businesses have historically faced disparities in securing the necessary funding required to scale their business. As market conditions worsened in 2022, it became more difficult for businesses to secure venture capital. At the same time, a larger number of diverse businesses found themselves needing traditional credit just to cover operating expenses as opposed to financial capital expenditures or expansion, which led to weaker future viability for these businesses.

To execute on American Water's development strategy to grow and scale diverse and small businesses for long-term growth, the company continues to work with suppliers who have significant vulnerabilities with cash flow management. Working and negotiating with these businesses on payment terms allows them to limit their dependence on external funding sources to meet operating expenses and focus on expansion efforts.

In addition to financial pressures, diverse businesses across all utility markets have also been limited by labor shortages, limited experience in the water industry, the density and geography of projects, and the complexity of leveraging workforce efficiency. Illinois American Water and Midwestern American Water entities will host the first Regional Supplier Diversity Symposium to support opportunities in Illinois, Missouri, Indiana and Iowa. American Water is responding to the feedback of diverse suppliers that contracting engagements with multiple states will support the volume and geographic density of projects to provide market competitive rates.

## M3 Engineering Group | Disadvantaged Business Enterprise

M3 Engineering Group, with offices in Chicago and St. Louis, provides engineering planning and design support for public and private clients on a variety of civil and environmental engineering projects, with a focus on water, wastewater and storm water.

The firm was founded in 2009 by Marjorie Melton P.E., LEED AP, Marc Eshelman P.E., and Todd Williams P.E. Melton, as one of a small group of African-American female engineers, made M3 eligible for certification as a Disadvantaged Business Enterprise. M3 began partnering with Illinois American Water in 2018 on a smoke testing project in Rollins, IL. Moving forward, Illinois American Water was impressed by M3's depth of expertise in wastewater solutions and hydraulic modeling, as well as their commitment to Diversity, Equity and Inclusion. One of the biggest projects to date the two companies have partnered on is the remediation of four cases of Sanitary Sewage Overflow (SSO) that was impacting clean water sources in Godfrey, IL.

When Illinois American Water purchased the wastewater system from the town of Godfrey, it included an EPA Consent Decree to fix the problematic SSOs. It entailed submitting a Corrective Action Plan (CAP) to the EPA that would draw upon M3's expertise in hydraulic modeling.

Hydraulic modeling is digital/mathematical modeling used to examine current systems and how wastewater flows can create bottlenecks within the system. The Godfrey project included analyzing the impact of a "synthetic storm".

"For the Godfrey project, we were required to see how a major-magnitude '25-year storm' would impact the system. Then, we were able to see problem areas that we addressed in the new plan," Williams said.

The biggest challenge? Getting permission from private owners to work on their properties. Once that was addressed, the project has moved smoothly and is expected to be completed in Fall 2023.

Shared values, trust and mutual respect characterize the partnership between M3 and Illinois American Water. "I've worked in engineering for 37 years, and Illinois American is probably my favorite client I've ever worked with," Eshelman (principal/founder) said.
